**Cancellations:** Cancellation and Refund Policy:

Notification of cancellation must be received in writing. At the time we receive your written cancellation, the following penalties will apply:

- ❖ No cancellation fee before June 15, 2019.
- ❖ After June 15, 2019, a \$500 cancellation fee will apply.
- ❖ No refunds after August 15, 2019.

Aurora Theater Company and Dramarama Theater Tours (DTT) reserve the right to cancel the tour and refund all payment if the tour does not reach minimum capacity. No refunds will be made for missed performances, meals, alternate transportation, sightseeing tours, absences or any other unused portion of the tour.
