**Cancellations:** Cancellation and Refund Policy:

Notification of cancellation must be received in writing. At the time we receive your written cancellation, the following penalties will apply:

- ❖ Cancellation before January 15, 2019, deposit returned in full.
- ❖ Cancellation after January 15, 2019 to February 28, 2019, 50% of deposit.
- ❖ No refunds after February 28, 2019.
