**Reservations:** A \$1000 per person deposit, along with a completed and signed reservation form, will reserve a place for each participant(s) on this program. The balance of the trip is due on or before August 15, 2019.

**Cancellations:** Cancellation and Refund Policy: Notification of cancellation must be received in writing. At the time we receive your written cancellation, the following penalties will apply:

- ❖ No cancellation fee before June 15, 2019.
- ❖ After June 15, 2019; \$500 cancellation fee will apply.
- ❖ No refunds after August 15, 2019.

Dramarama Theater Tours (DTT) reserves the right to cancel the tour and refund all payment if the tour does not reach minimum capacity. No refunds will be made for missed performances, meals, alternate transportation, sightseeing tours, absences or any other unused portion of the tour. DTT does not accept liability for cancellation penalties related to domestic or international airline tickets purchased in conjunction with the tour.

**Itinerary Changes & Trip Delays:** The itinerary is based on information available at the time of printing and is subject to change. We reserve the right to change a program's dates, staff, itineraries or accommodations as conditions warrant. If a trip must be delayed, or the itinerary changed due to bad weather, road conditions, transportation delays, airline schedules, government intervention, sickness or other contingency for which DTT or its agents cannot make provision, the cost of delay of changes is not included.

**Limitations of Liability:** DTT, its Owners, Agents and Employees act only as the agent for any transportation carrier, hotel, ground operator, or other suppliers or services connected with this program ("other providers") and the other providers are solely responsible and liable for providing their respective services. DTT shall not be held liable for (A) any damage to, or loss of, property or injury to, or death of, personas occasioned directly or indirectly by an act or omission of any other provider, including but not limited to any defect in any aircraft, or vehicle operated or provided by such other provider, and (B) any loss or damage due to delay, cancellation or disruption in any manner caused by the laws, regulations, acts or failures to act, demands, orders, or interpositions of any government or any subdivision or agent thereof, or by acts of God, strikes, fire, flood, war, rebellion, terrorism, insurrection, sickness, quarantine, epidemics, theft, or any other cause beyond their control. The participant waives any claim against DTT for any such loss, damage, injury, or death. By registering for the trip, the participant certifies that he/she does not have any mental, physical or other condition or disability that would create a hazard for him/herself or other participants. DTT shall not be liable for any air carrier's cancellation penalty incurred by the purchase of a non-refundable ticket to or from the departure city. Baggage and personal effects are at all times the sole responsibility of the traveler. Reasonable changes in the itinerary may be made where deemed advisable for the comfort and well-being of the passengers.
